Researchers updated country information based primarily on secondary research data and interviews with relevant stakeholders. The regional barometer goes hand in hand with the accompanying 2012 country Barometers for all 15 SADC countries available online or CD Rom. This year's barometer has two key new features. The first is Chapter 11 on Gender, Climate Change and Sustainable Development. The first of three volumes, this book traces the leadership thoughts and philosophical disposition of Professor Arthur G.O. Mutambara over a period of 35 years, as his generation sought to become the transformation it wished to see in Zimbabwe. The trilogy constitutes a fascinating intellectual and political journey by the man who would become Deputy Prime Minister of Zimbabwe at the age of 42. It is a collection of grounded reflections that he expressed over time, as he endeavoured to move, lead and inspire people, while turning strategic thinking into reality through the speed of execution. Mutambara's ambition has always been to change the world by igniting citizen activism. It is an epic journey of ideas that created evolutionary and even revolutionary advancement of democratic values, institution-building, social justice, empowerment, shared economic prosperity, people-centred governance and efficacious statecraft. The intrinsic value and relevance of the prescriptions proffered are both enduring and timeless. This volume deals with his formative years and early professional life. This period constitutes the making of a leader of global stature. His profound odyssey of thought leadership started at the age of 16, and moved through the University of Zimbabwe (UZ), where he graduated with a BSc (Hons) in Electrical Engineering. A statement he wrote as a student leader led to the unprecedented closure of UZ. He was injured and detained. His journey of ideas then proceeded to the University of Oxford, where he obtained an MSc in Computer Engineering and a PhD in Robotics and Mechatronics. The next stop was the United States, where he was a Research Scientist at NASA, Professor at MIT and Management Consultant at McKinsey. The book ends with his return to the continent in 2002, equipped with Pan-African, business- and technology-driven developmental strategies and paradigms.

Challenging disadvantage in Zambia: People with psychosocial and intellectual disabilities in the criminal justice system / Paralegal Alliance Network (PAN)

This project investigated how individuals with psychosocial and intellectual disabilities are dealt with by the criminal justice system in Zambia, and developed recommendations for improving policy and practice. The vast majority of people interviewed for this study said that people with psychosocial and intellectual disabilities face stigma and discrimination in society, generally. It is inevitable that discriminatory attitudes, including widespread assumptions that such individuals lack capacity and have little to contribute to society, pervade public services and how people with psychosocial and intellectual disabilities are dealt with by public services personnel. At least until recent years, such attitudes were reflected also in national legislation which did not afford people with disabilities the same rights as were granted to those without disabilities, and frequently contained discriminatory language and provisions. This study has shown that people with psychosocial and intellectual disabilities in contact with criminal justice services are disadvantaged and discriminated against routinely and systematically. Like all detainees, they experience the harsh and at times brutal conditions of detention, including violence and abuse from officers and other detainees. However, their disabilities may render them more vulnerable to the negative impact of such experiences. The legislative framework and lack of community services conspire to create a disproportionate and potentially discriminatory police response to people with psychosocial and intellectual disabilities, at times when they are in most need of sups.

With reportedly over USD100 billion lost annually through graft and illicit practices, combating corruption in Africa has been challenging. However, laws and policies at the continental, regional and national levels have been promulgated and enacted by African leaders. These initiatives have included the establishment of anti-corruption agencies mandated to tackle graft at national level, as well as coordinate bodies at regional and continental levels to ensure the harmonisation of normative standards and the adoption of best practices in the fight against corruption. Yet, given the disparity between the apparent impunity enjoyed by public servants and the anti-corruption rhetoric of governments in the region, the effectiveness of these agencies is viewed with scepticism. This continent-wide study of anti-corruption agencies aims to gauge their relevance and effectiveness by assessing their independence, mandate, available resources, national ownership, capacities and strategic positioning.
