Set against a contemporary South African society that is chronologically 'post' apartheid, but one that continues to grapple with material redress, land redistribution and systemic racism, Acts of Transgression finds a representation of the complexity of this moment within the rich potential of a performative art form that transcends disciplinary boundaries and aesthetic conventions. The collection probes live art's intersection with crisis and socio-political turbulence, shifting notions of identity and belonging, embodied trauma and loss, questions of archive, memory and the troubling of colonial systems of knowing, an interrogation of narratives of the past and visions for the future.

These diverse essays, analysing the work of more than 25 contemporary South African artists and accompanied by a striking visual record of more than 50 photographs, represent the first major critical study of contemporary live art in South Africa; a study that is as timeous as it is imperative.

In Search of the Elusive Zimbabwean Dream: An Autobiography of Thought Leadership, Volume II: The Path to Power (2003-2009) / Arthur G.O. Mutambara Auckland Park, Johannesburg: Staging Post, 2018 xxii, 426p. 9781928440048 \$ 50.00 / PB 870gm.

This is the second of three volumes in a series that traces the leadership thoughts and philosophical disposition of Professor Arthur G.O. Mutambara over a period of 35 years. The dramatic removal of Robert Mugabe by a peoplebacked coup d'etat in November 2017 was greeted with euphoria and high expectations. However, the ensuing goodwill was rapidly squandered – the dream was deferred. Zimbabwe's elections in July 2018 generated tremendous hope – the exhilaration for change was palpable. Alas, it was not to be. The vision of a peaceful, democratic and wealthy nation characterised by inclusive economic growth and shared prosperity – the 'Zimbabwean Dream' – has proven difficult to attain. In fact, this ambition has been hard to achieve in most African countries. Hence, Mutambara's work is in search of the elusive 'African Dream'. The trilogy constitutes a fascinating intellectual and political journey by the man who would become Deputy Prime Minister of Zimbabwe at the age of 42. It is a collection of grounded reflections presented together with selected autobiographical material. The work is a product of rigorous and peer-reviewed research and analysis. It contributes to the epistemology of thought leadership from the perspective of an engineer-cum-politician, bridging the knowledge gap between the two disciplines. This volume - The Path to Power - deals with Mutambara's return to Africa from the United States and his re-entry into Zimbabwean politics, leading to his swearing-in as Deputy Prime Minister. The book discusses the build-up to the disputed 2008 elections and the chaotic aftermath. An erudite and blistering speech Mutambara gave led to his arrest and detention. Neither SADC nor the AU recognised the sham and genocidal June 2008 run-off election. This led to the SADC mediation efforts, facilitated by SA's Thabo Mbeki. The intervention produced the GPA – the basis for the GNU. This well-researched book is the first literary contribution by someone intimately involved with both the GPA and GNU. In 2018, with the rigging of elections in Zimbabwe now at an industrial scale, the book articulates the lessons to be drawn from such polls. It proffers a strategic way forward – the path to power. The book is organised into three sections: Return to Africa and Re-entry into Politics (2003–2005); Building a Viable Alternative to ZANU-PF (2006–2007); and Journey Towards the GNU (2008-2009).

A quest is never what you expect it to be.

Elizabeth Madeline Martin spends her days in a retirement home in Cape Town, watching the pigeons and squirrels on the branch of a tree outside her window. Bedridden, her memory fading, she can recall her early childhood spent in a small wood-and-iron house in Blackridge on the outskirts of Pietermaritzburg. Though she remembers the place in detail – dogs, a mango tree, a stream – she has no idea of where exactly it is. 'My memory is full of blotches,' she tells her daughter Julia, 'like ink left about and knocked over.'

Julia resolves to find the Blackridge house: with her mother lonely and confused, would this, perhaps, bring some measure of closure? A journey begins that traverses family history, forgotten documents, old photographs, and the maps that stake out a country's troubled past – maps whose boundaries nature remains determined to resist. Kind strangers, willing to assist in the search, lead to unexpected discoveries of ancestors and wars and lullabies. Folded into this quest are the tender conversations between a daughter and a mother who does not have long to live.

Taken as one, The Blackridge House is a meditation on belonging, of the stories we tell of home and family, of the precarious footprint of life.

A writer of singular verve, humour and descriptive power, his memoir provides penetrating pen portraits of many well-known South African and African political actors, including martyred UMkhonto we Sizwe guerilla Solomon Mahlangu, Nigeria's Olusegun Obasanjo, Robert Mugabe and a galaxy of senior ANC exiles such as Joe Slovo, Chris Hani, Josiah Jele, Joel Netshitenzhe and Mac Maharaj.

He touches on and illuminates the personalities of many influential men and women in South Africa's early democratic governments. But the heart of Mavimbela's narrative lies in his unique experience of working as a top administrator and counsellor in the offices of Thabo Mbeki and Jacob Zuma. In the most intimate detail, he describes the emergence and escalation of the conflict between those two flawed principals. He captures the drama of their struggle and its destructive fallout for the new South African state. Mavimbela offers a potent warning: loyalty and long service to a political party is no guarantee of wise and effective leadership.

The humble and industrious dung beetle is a marvelous beast: the 6 000 species identified so far are intricately entwined with human history and scientific endeavour.

These night-soil collectors of the planet have been worshipped as gods, worn as jewellery, and painted by artists. More practically, they saved Hawaii from ecological blight, and rescued Australia from plagues of flies. They fertilise soil, cleanse pastures, steer by the stars, and have a unique relationship with the African elephant (along with many other ungulates). Above all, they are the ideal subject for biological study in an evolving world.

In this sweeping history of more than 3 000 years, beginning with Ancient Egypt, scientist Marcus Byrne and writer, Helen Lunn capture the diversity of dung beetles and their unique behaviour patterns. Dung beetles' fortunes have followed the shifts from a world dominated by a religion that symbolically incorporated them into some of its key concepts of rebirth, to a world in which science has largely separated itself from religion and alchemy.

With over 6 000 species found throughout the world, these unassuming but remarkable creatures are fundamental to some of humanity's most cherished beliefs and have been ever present in religion, art, literature, science and the environment. They are at the center of current gene research, play an important role in keeping our planet healthy, and some nocturnal dung beetles have been found to navigate by the starry skies. Outlining the development of science from the point of view of the humble dung beetle is what makes this charming story of immense interest to general readers and entomologists alike. In *The State and the University Experience in East Africa*, Professor Kithinji explores the critical yet unacknowledged role that universities have played in the politics of statehood and nation-building, demonstrating how successive colonial and postcolonial governments have sought to use university education as a means to advance political and economic interests, he seeks to unravel the connection between universities and the state in East Africa, particularly in Kenya. The forces that have influenced the development of universities are explored by thorough narrative and analytical history of the policies and politics of university education in the past half-century and more.

This study identifies three major policy trends that have shaped university education, beginning from 1949, when the British colonial government founded Makerere University College in Uganda as the first degree granting institution for East Africa, until 2002, when the second President of Kenya, Daniel arap Moi, retired from office and his Kenya African National Union (KANU), that had ruled since independence in 1963, lost power.

By investigating the dynamics that have influenced higher-education policies in Kenya and the wider East African region, this study links the higher education discourse with the state-building narrative and conceives university policies as a product of the forces informing the historical trajectory of Kenya in particular and the wider East African region in general. *The State and the University Experience in East Africa* will be of great interest to scholars of the African continent, some of whom may be inspired to rewrite the story of tertiary education and state formation in other parts of Africa by an equally meticulous examination of primary sources as demonstrated in this work. http://www.marymartin.com/web?pid=583381

Following the bombing of the Sibasa police station in October 1981, the Vendaland security police persecuted four Lutheran church pastors. This book tells the story of two of these men. The first-person experience of torture of Ndanganeni Peter Phaswana, ably refracted through his capacity for reflection on forgiveness and reparation, offers one lens. The second lens is via the experience of Lillian Tendani Muofhe, as she sought to absorb the murder of her revered husband Isaac Tshifhiwa Muofhe, while mothering her infant daughter. Both accounts hold up a mirror to South African society, present and past, and offer powerful lenses for engaging with the ways in which trauma lodges, sometimes intractably, in the individual unconscious as well as in the collective unconscious of a society.

The adoption in 2013 of the Model Law on Access to Information for Africa by the African Commission on Human and Peoples' Rights is an important landmark in the increasing elaboration of human rights-related soft law standards in Africa. Although non-binding, the Model Law significantly influenced the access to information landscape on the continent. Since the adoption of the Model Law, the Commission adopted several General Comments. The AU similarly adopted Model Laws such as the African Union Model Law on Internally Displaced Persons in Addressing Internal Displacement in Africa.

This collection of essays inquires into the role and impact of soft law standards within the African human rights system and the AU generally. It assesses the extent to which these standards induced compliance and identifies factors that contribute to generating such compliance. This book is a collection of papers presented at a conference organised by the Centre for Human Rights, University of Pretoria, with the financial support of the government of Norway, through the Royal Norwegian Embassy in Pretoria. Following the conference, the papers were reviewed and reworked.

Adam Habib, the most prominent and outspoken university official through the recent student protests, takes a characteristically frank view of the past three years on South Africa's campuses in this new book. Habib charts the progress of the student protests that erupted on Wits University campus in late 2015 and raged for the better part of three years, drawing on his own intimate involvement and negotiation with the students, and also records university management and government responses to the events. He critically examines the student movement and individual student leaders who emerged under the banners #feesmustfall and #Rhodesmustfall, and debates how to achieve truly progressive social change in South Africa, on our campuses and off. This book is both an attempt at a historical account and a thoughtful reflection on the issues the protests kicked up, from the perspective not only of a highranking member of university management, but also Habib as political scientist with a background as an activist during the struggle against apartheid. Africa Reimagined is a passionately argued appeal for a rediscovery of our African identity. Going beyond the problems of a single country, Hlumelo Biko calls for a reorientation of values, on a continental scale, to suit the needs and priorities of Africans. Building on the premise that slavery, colonialism, imperialism and apartheid fundamentally unbalanced the values and indeed the very self-concept of Africans, he offers realistic steps to return to a more balanced Afro-centric identity.

Historically, African values were shaped by a sense of abundance, in material and mental terms, and by strong ties of community. The intrusion of religious, economic and legal systems imposed by conquerors, traders and missionaries upset this balance, and the African identity was subsumed by the values of the newcomers.

Biko shows how a reimagining of Africa can restore the sense of abundance and possibility, and what a rebirth of the continent on Pan-African lines might look like. This is not about the churn of the news cycle or party politics – although he identifies the political party as one of the most pernicious legacies of colonialism. Instead, drawing on latest research, he offers a practical, pragmatic vision anchored in the here and now.

By looking beyond identities and values imposed from outside, and transcending the divisions and frontiers imposed under colonialism, it should be possible for Africans to develop fully their skills, values and ingenuity, to build institutions that reflect African values, and to create wealth for the benefit of the continent as a whole.
