Press freedom plays a significant role in creating public awareness via accurately informing the society. It performs this duty within the framework of respect to diversity of opinions and individual right to self-governance, which is particularly indispensable to liberal democracies.

Press freedom is a different form of freedom of expression, which is included in the most fundamental human rights documents such as the UN Universal Declaration of Human Rights, the UN Universal Covenant on Civil and Political Rights, and the European Convention on Human Rights (ECHR). Freedom of expression has been protected under Article 10 of the ECHR. This article draws the boundaries of this right as freedom to hold opinions and impart information and ideas without interference by public authority and regardless of frontiers. The article then instructs the acceptable limits of this freedom. In order for a restriction of freedom of expression be valid, it must be prescribed by law first, and secondly, it must be necessary in a democratic society, and finally it must be only aimed for the listed legitimate causes as specified in this article.

Despite the protection of the ECHR Article 10, Turkey has seen frequent interventions on the press due to political pressure and the ownership structure of the media in the country. And consequently, numerous violation judgments have been delivered by the European Court of Human Rights (ECtHR), which will be analyzed in terms the reasons for violations and the

cases of legitimate restrictions on press freedom. Additionally, this book will give a detailed trajectory of press freedom in Turkey in the light of court decisions, European Union Progress Reports and statements of press unions.

Why the state founders of Israel and the Turkish Republic, despite being mostly secular and looking initially to create a secular state, chose to integrate religion into the state sphere by incorporating religious institutions into the state apparatus? Part of the answer relates to the objective of achieving national homogeneity, as one of the striking similarities between the two countries. The state elite in both countries encountered the same urgent issue after declaring independence – the formation of a national unity. This book makes a comparison of the relationship between the state, religion and nationalism in the State of Israel and the Republic of Turkey during their state-building processes. Existing literature analyzing the relationship between the state and religion in Israel and Turkey reveals that both have been conceived as secular, democratic, modern states, and Israel can be put forward as exceptional case in the Middle East. That said, there is a need to include the issue of secularism in the national, historical contexts of both states to gain a better understanding of the issue. To this end, this book delineates the similar and different paths followed by the State of Israel and the Republic of Turkey concerning their experiences with secularism, and argues that, contrary to general assumptions that emphasize their uniqueness in the region; the two share various similarities and indeed are not unique.

The fifth book of the “Sounds of Silence” series has been published with the support of Consulate General of Sweden and Consulate General of Netherlands. Kayseri's Armenians Speak, is a product of the oral history project carried out since 2011 by Hrant Dink Foundation. The Sounds of Silence - 5: Kayseri's Armenians Speak, which compiles 10 out of the 28 interviews.

The book contains, in addition to the oral history interviews conducted, the introduction by the historian Dr. Mehmet Polatel and the afterword by the editor Dr. İclal Ayşe Küçükırca, whom are members of the Hrant Dink Foundation's History Program.

Kayseri's Armenians Speak is taking us to a visit through the memoirs of the Armenian society. This book is giving clues about the “self” and “other” perception the Armenian society carries, by giving examples on the deportation and genocide memories transmitted through generations, as the other books of the series.

Kayseri was one of the rare cities in which Armenians continued to live during the Republican period, with 1,978 Armenians registered there according to the 1927 census. This total dropped to 1,600 in 1932, to 800 in 1960 and to zero today. After the migration of Armenians living in various areas of Anatolia to Istanbul, predominantly in the 1950s, a significant number of Armenians from Kayseri gathered in the Samatya district in particular.

This book compares religion-state relations in Turkey and Iran by adopting a historical perspective. It explores the various historical trajectories, international developments and cultural elements that generated distinct religion-state relations in these two national contexts. It argues that the main determinants of this relation derive from the varying degrees of institutionalisation of religious establishments. Historical analysis reveals that the Turkish state inherited a type of state tradition in which religion was strongly controlled and incorporated to the state structure. Conversely, in Iran, especially after the Safavid period, state tradition was marked by the relative autonomy of religious establishments from the state. The influence of international factors on religion-state dynamics is also analyzed. Direct international factors are found to have been more influential in the Iranian case whereas in the Turkish case indirect factors played a more decisive role. This book also argues that it is misleading to point to differences between Shi'a and Sunni sects in an essentialist manner to explain the different paths that these two countries followed

In numerous European countries, there has been a wave of prohibitions against Islamic practices ranging from ritual animal slaughter to the building of mosque minarets, from male circumcision to women's headscarves. Moreover, religious conservatives among the Muslim minority are almost completely excluded from the national legislatures. As such, there is a "representation gap" between conservative Muslims and their leftist representatives. This ideological disconnect between the Muslim constituencies and their representatives can be observed in almost every continental European country, and it seems to persist across time. Despite major improvements in some countries over the last decade, Muslim minorities are still underrepresented in the national legislatures of most Western European countries.

Unfortunately, the descriptive representation of Muslim minorities, that is, Muslim-origin MPs in the national legislatures, does not necessarily translate into the substantive representation of the religiously specific interests of the Muslim minorities.

Turkey, which is hosting the lion's share of Syrian refugees without foreign aid, can serve as an example to the world. In this effort, Turkey's citizens are to be applauded for their hospitality towards the war victims. However, as time goes by most of the refugees show no sign of returning, thus creating problems that can only be

resolved by the development of a long-term policy. The aim of this book is to investigate the level of understanding their permanence within Turkish society and to explore possible solutions for their permanent integration, For this purpose the Federal Republic of Germany was seen as an immigrant target country in which recent accelerated integration was taken as the model for the study. The applicability of its integration policy was examined for Turkey with the aim of presenting the National Integration Plan of the Federal Republic of Germany, the major dominating Germany's integration policy, as a possible model for future Turkish policy during the integration process.
