[In the introduction to this book Arif Hasan states: "During the last century, and specially since Independence, major demographic, social and economic changes have taken place in Pakistan. These changes are so enormous that they can be termed revolutionary. However, they have not been institutionalized in any form. The result is that the manner in which the Pakistan state is structured and governed, the manner in which its fiscal system operates, and development is conceived, managed and implemented, does not reflect the changed demographic, social, cultural and economic realities. This in turn has resulted in the creation of parallel systems of governance in defiance of state laws and regulations; political and cultural alienation of increasingly large sections of population; social anarchy and the resulting administrative and judicial helplessness.

"There are many manifestations of socio-economic change in Pakistan. Three of them are of a very fundamental nature and are closely inter-related. One is the emergence of an aggressively upwardly mobile migrant culture which is the result of the refugee influx at the time of the partition of India and the migration of Pakistanis to the Middle East in the 1970s and 1980. The second is the demise of the feudal order as an effective arm of the establishment, and the third is rapid urbanization."

In subsequent chapters he goes on to look at the repercussions of these changes on the lives of the rural and urban communities he has worked and associated with since 1968; on the physical environment; and on the old clan-based system of governance. He describes this process of change and identifies the actors involved in it (victims, beneficiaries and activists) along with their aspirations, and government's responses to their problems.]

[If indeed, as is often said, the past is prologue, then the roots of much of the trauma and travail in the recent history of Kashmir can be traced back to the years when it was a princely state during the British Raj. In 1846, the lucrative province of the Punjab at last came under British rule. Instrumental in the acquisition was the Dogra Raja of Jammu, Gulab Singh. With the desire to reward him, the British at the same time created a northern buffer between India proper, the advancing Russian battalions to the north-west, and the sleeping giant China to the north-east. In the years before the Dogra ascendancy, Kashmir was ruled by various dynasties, the Mughals, the Afghans, and the Sikh Khalsa. To all these strangers, the valley and its environs provided a playground and an escape from the searing summer heat of the surrounding hills and plains. Climate and natural beauty were, however, not all that lured the invaders to Kashmir. The Strategic importance of the valley, astride the routes to Central Asia, and the incomparable shawl wool looms proved to be even more irresistible temptations. The relationship between British India and Kashmir was rarely untroubled and at the heart of much of the turmoil lay the fact that predominantly Muslim Kashmir was ruled by a Hindu princely family.

Kashmir and the British Raj, 1847-1947 focuses on the century before Partition. The book is based almost entirely on archival sources, specifically those of the India Office Library in London-and is a valuable addition to the increasingly abundant literature on Kashmir.]

However, Sanskrit dictionaries, like Arabic ones, are based on roots. Therefore it is possible in some cases to relate Western Indo-European roots to Sanskrit ones. That is what Khaled Ahmed has done in this book. It is different from other works on etymology in that it enlists words common to Eastern and Western language groups.

Barring early philologists like Muller and Jones, no one has so far tried to look at this shared aspect. This is the unexplored field of discovery and consequent excitement that this book wishes to share with readers. For instance, kana is "reed" in Punjabi; so is it in Greek. In the Western group, Greek kana has given rise to words like "canal", "channel", "Canon", etc. In Skand Gupt, which is the name of an Indian king, skand means "jump"; in Persian, skand means the same; in English "ascend", the root skand means "jump". In Harsha, another Indian king, the root hr means "hair" rising under a sensation of joy; in Persian haras, it means "hair" rising under a

sensation of fear; in English, "horror" means "hair" rising under a sensation of terror. This is the kind of verbal adventure the book promises.

This book will be of use to specialists in search of more shared words across the East-West divide of the Indo-European languages. It is also guaranteed to excite the common reader of language.]
