[Anton Explores a lot of Balinese ritual decorative elements. This artistic theme was expanded into making puppets (or wayang) and masks. The theme was later on crystallized into decorative paintings. During this period, Anton was already highly regarded by spectators and curators in the country and around world. Joseph Fischer and Helena Spanjaard very extensively observed his artworks. They included Anton's work in important exhibitions such as KIAS (Indonesian cultural event in the US). Other curators took his paintings to be exhibited in Amsterdam, East-West Centre, Hawaii and during the "From ritual to Romance" exhibition in Singapore. Meanwhile, a number of his admirers also brought his work to other exhibitions in Germany, Netherlands and Denmark. As a result of the inclusion in these high profile exhibitions, during the Jakarta international Fine Art exhibition in 1994. Anton's paintings were considered masterpiece. It can be seen from his work, that during the last era of his career, he was influenced by Ejler Bille, one of the artists of Cobra (Copenhagen, Belgium and Amsterdam). However, Anton's skill in Indonesian traditional visual elements has resulted in his work to be considered unique and original.]

IN 1953, as part of the Eisenhower/Dulles response to Senator Joseph McCarthy's charges of security risks in its staff, John Bresnan was fired from the U.S. foreign service. This turned out to be a blessing in disguise as he was quickly hired by the Ford Foundation in its New York headquarters, and in 1961 was appointed Assistant Representative to Indonesia. Four years later, Bresnan was given another assignment: close the office.

What follows is a personal recollection of the philanthropic work by the Ford Foundation during a critical period of development for the country. It details the Ford Foundation's successes and failures as well as his relationships with a wide array of characters: from John D. Rockefeller III to Soedjatmoko, from McGeorge Bundy to the Sultan of Yogyakarta.

Based on extensive research in the archives of the Ford Foundation as well as personal files, At Home Abroad is an engaging insight into the inner workings of one of the largest philanthropic organizations and their mission in the developing world.

This book should be required reading for anyone interested in the role of American philanthropy overseas.

[Isidore van Kingsbergen (1821-1905) is some times described as the 'sleeping beauty' of nineteenth-century photography, because his remarkable body of work has never been presented in its entirety. Yet he was a flamboyant artist who appeals to the imagination. For the first time, this publication gives a broad overview of the exceptional qualities of this photo pioneer. Van Kinsbergen became famous for the almost four hundred photographs he took of Java's antiquities at the behest of the Dutch colonial government and the Batavian Society. Detailed research has also brought to light a hitherto unknown part of his oeuvre, including the portraits he made at the courts of Yogyakarta, Surakarta, Bandung, Madura and Buleleng (Bali). In his studio, he used his experience as a theatre director to photograph people from various social backgrounds in an expressive manner. Following nearly three decades of conflict and a series of failed ceasefire agreements, on 15 August 2005, the separatist Free Aceh Movement (GAM) and the Government of Indonesia reached an historic peace agreement to end the fighting and to give Aceh a high degree of genuine autonomy. The catalyst for the talks that produced this agreement was the devastating tsunami of 26 December 2004, which left almost 170,000 dead or missing in Aceh and destroyed most of the populated low-lying areas. Despite the massive destruction, the peace talks were conducted under an intensified military campaign. GAM made a major concession to the talks by announcing early that it was prepared to negotiate an outcome other than complete independence. The Indonesian side, however, under pressure from the military and "nationalists" in Jakarta, pressed for GAM to accept a minor reworking of the status quo. The international community, meanwhile, just pressed for a settlement. In the end, the Indonesian government also compromised, and the two parties reached an agreement that was intended to end the fighting and to address many, if not all, of GAM's outstanding claims. Despite opposition to the talks process, and to compromise, the outcome was increasingly seen both in Jakarta and in Aceh as a "win-win" situation, and as a further significant step in Indonesia's continuing process of reform and democratization. Peace in Aceh offers an insider's personal account of that peace process and is required reading for anyone wishing to understand this troubled province.

[Complicity in Genocide was originally commissioned by the United Nations-backed East Timor Commission for Reception, Truth and Reconciliation, also known by its Portuguese acronym, CAVR. Part of a national and international team of human rights investigators, the author worked in CAVR headquarters in Dili, East Timor, in June-July 2003. Needless to say, all components of the CAVR final report – the author's submission included – were subject to extensive discussion and edition by CAVR commissioners.

With the completion of CAVR's mission in October 2005, the final report dubbed *Chega!* or *Enough!* was presented to the East Timor President for ratification prior to submission to parliament and to the UN Secretary – General. But in presenting the report to the East Timor legislature, the President described recommendations relating to reparations from countries that had supplied weapons and military training to the Indonesian armed forces as "politically unrealistic".

While widely welcomed by the human rights community and the East Timor public, *Chega!* is largely silent on Western arms suppliers to the Indonesian armed forces along with the role of the ASEAN countries and Japan in succoring the Jakarta regime. It would even seem that CAVR commissioners did not wish to offend its principal international donors, namely Japan, Australia and the United States. Many of the omissions in *Chega!* relating to international actors are spelled out in the author's submission.
