The Sarawak Land Code is a unique piece of legislation, reflecting the historical development of the State's land administration system since the arrival of the first Rajah in 1841 and the customs and traditional way of life of its multi-ethnic communities, but incorporating provisions which had facilitated the rapid social and economic changes and progress enjoyed by the State since 1 January, 1958 when this law came into force.

Enacted during the colonial Administration, the Land Code had undergone multiple amendments but no revision yet under the Revision of Laws Ordinance, 1993.
