Regulations that run counter to the logic of normal market practices, that give entrepreneurs few opportunities to enter into contractual relationships, or that penalize them for market success are bound to be circumvented, at significant social cost. To complete its reform agenda, and improve education and health outcomes, Vietnam will need a better governance. This third challenge may be the most difficult of all.]
