But there are ethical goals and self-reflections; social attitudes and pragmatic shrewdness, as well as a sense of time passing, which should be cultivated in any case if one is to live a full and meaningful life. The Top may not be a place that we can easily locate. As Egawa-san puts it:

"Being alive, we should, at least until we have aged too much, recompense and respect our situation by undertaking responsible work as human beings. Before we know it, we would have reached a certain age beyond which daily quietude, good health and physical safety become paramount. All the rest power, position, business results, assets, lust, et cetera are but brief moments, simply passing scenery."

Inaugural Lecture of the Darul Ehsan Public Lecture series by Professor Dr. Mohd Faiz bin Abdullah (Dean of Selangor Business School, UNISEL) delivered on 19 September 2017

In this short monograph, the author proposes to shed light on the transformation of Selangor into a regional smart state. He defines the term "Smart State" and examines the theoretical foundations of paradigm change touching on the Kuhn-Popper debate concerning falsifiability. The author contends that this discourse has been dominated by Western scholarship viewed from secular-oriented lenses. He presents his alternative perspective from the prism of Islam and revealed knowledge as articulated in his first two books, *The Province of Shariah Determined – Fundamental Rethink of the Shariah and Wars of Jurisprudence – Clash between Contractual Justice and Freedom of Contract*. The author discusses questions on managing strategic change, leadership and strategic management doctrines and principles. Having set the theoretical discourse, he presents some key case studies to support the contention that propelling change for the state of Selangor is neither rhetoric nor polemics but supported by facts, figures and tangible results. The author makes the case for continued support for transformational change made even more pressing by the advent of the Fourth Industrial Revolution. Good governance, accountability and transparency and social justice are posited as critical success factors for the transformation. He proposes some strategic formulations in respect of the key steps to further drive the change process and propel the transformation trajectory.

"L'intégration régionale des territoires français du Pacifique (les TFP, qui comprennent la Polynésie française, la Nouvelle-Calédonie, Wallis-et-Futuna) est-elle souhaitable ? En 1995, il y a donc vingt ans aujourd'hui, Jean Freyss se livrait à une analyse novatrice de l'économie calédonienne en soulignant un paradoxe majeur : riche de son nickel, potentiellement la plus autonome de l'outremer, elle reste très largement dépendante des transferts de la métropole (Économie assistée et changement social en Nouvelle-Calédonie, PUF, 1995). Financées par le Fonds de coopération économique, sociale et culturelle pour le Pacifique du ministère des affaires étrangères, ces recherches montrent combien le paradoxe mis en avant par Jean Freyss conserve toute son actualité et ont pour ambition de nourrir la réflexion autour de la problématique de l'intégration régionale. En effet, ces territoires (les TFP) ont en commun leur éloignement de la métropole et le bénéfice de transferts financiers issus de cette dernière. Ils demeurent donc privilégiés au sein du Pacifique en termes de développement au point que leurs économies sont souvent considérées comme artificielles. Leurs situations sont proches en ce qui concerne la cherté de la vie et les surcoûts, dont la mécanique est précisément ici décrite, de même que les phénomènes de marges.
