This fascinating study unveils the workings of the Indonesian migration regime, one that sends hundreds of thousands of women abroad as domestic workers each year. Drawing on extended ethnographic research since 2007, the book literally follows migrant women from a matrilineal village in upland Central Java, women who actively place themselves in a position to enter the migration pipeline, knowing that their lives abroad will be hard and even dangerous, and that staying in the village is an option. From recruitment by local brokers to the 'training' received in secluded camps in Jakarta, employment in gated middle-class homes within Indonesia and in Malaysia and back home again, Olivia Killias tracks the moral, social, economic and legal processes by which women are turned into 'maids'. The author's analysis uncovers the colonial genealogies of contemporary domestic worker migration and demonstrates that, ironically, the legalization of the migration industry does not automatically improve the situation of the women in its care. Rather, Killias unmasks the gendered moralizing discourses on 'illegal' migration and 'trafficking' as legitimizing indentured labour and constraining migrant mobility. By exploring the workings of the Indonesian state's overseas legal labour migration regime for migrants, she brings the reader directly into the nerve-racking lives of migrant village women, and reveals the richness and ambiguity of their experiences, going beyond stereotypical representations of them as 'victims of trafficking'.

Organise or Die? Democracy and Leadership in South Africa's National Union of Mineworkers is the first in-depth study of one of the leading trade unions in the country. Founded in 1982, the trade union played a key role in the struggle against white minority rule, before turning into a central protagonist of the ruling Tripartite Alliance after apartheid. Deftly navigating through workerist, social movement and political terrains that shape the South African labour landscape, this book sheds light on the path that led to the unprecedented 2012 Marikana massacre, the dissolution of the Congress of South African Trade Unions (Cosatu) federation and to fractures within the African National Congress (ANC) itself.

Working with the notions of organisational agency and strategic bureaucratisation, Raphaël Botiveau shows how the founding leadership of NUM built their union's structures with a view to mirror those of the multinational mining companies NUM faced. Good leadership proved key to the union's success in recruiting and uniting mineworkers and NUM became an impressive school for union and political cadres, producing a number of South Africa's top post-apartheid leaders. An incisive analysis of leadership styles and strategies shows how the fragile balance between an increasingly distant leadership and an increasingly militant membership gradually broke down.

As Taiwan is becoming a destination to which an increasing number of Hong Kong people are contemplating emigrating, the experiences of Hong Kong immigrants who settled in Taiwan somewhat earlier might be instructive. This is a qualitative study involving interviews with 40 Hong Kong people (22 males and 18 females) aged between 39 to 77, who came to Taiwan between 1945 and 2002. The sample and family migrants, dispatched employees, and entrepreneurs. Most have settled down successfully in a variety of white collar professional jobs. Despite similarities in Chinese culture, Hong Kong people face various difficulties with the culture and customs of Taiwan. A lack of ability to speak Minnan, the major dialect of local Taiwanese, or the persistence of a Cantonese accent when speaking Mandarin, may have alienated their integration by acting as an obstacle to obtaining a better understanding of the dynamics of human relationships in Taiwan. Moreover, they encountered various cultural differences. Earlier female immigrants, in particular, found Taiwanese society to be much more patriarchal than that of Hong Kong.

Keaveney explains the origins of the cultural construct "Samurai baseball" and reflects on the recurrences of these essentialist discourses at critical junctures in Japan's modern history. Since the early modern period, writers, filmmakers, and manga artists have alternately affirmed and debunked these popular myths of baseball. This study presents an overview of these cultural products, beginning with Masaoka Shiki's pioneering baseball writings, then moves on to the long history of baseball films and the venerable tradition of baseball fiction, and finally considers the substantial body of baseball manga and anime. Perhaps what is most striking is the continuous relevance of baseball and its values as a point of cultural reference for the Japanese people; their engagement with baseball is a genuine national love affair.
